

ITLOS database: Instructions for using the ITLOS library database

General Remarks:

The library is not open to the public. Therefore, please send your literature requests to the following e-mail address: donia.braham@studium.uni-hamburg.de or via phone message/WhatsApp: +49 176 64603535.

Books that have been borrowed from the library are not allowed to leave the ITLOS premises! However, the books may be used both in the main building and in Villa Schröder. Return the books to Donia Braham after use. If you want to use the books on the following day or beyond, return the books at the end of the day. The books will then be stored for you in the library and returned to you when you return to the ITLOS premises. It is possible to copy or print book chapters or individual pages in Villa Schröder.

Please handle resources carefully, as you are used to.

When ordering books, please specify the following:

- Your name
- Shelf number of the book
- Page numbers/chapters, if applicable
- If you need a copy or want to borrow the book for reading only
- If a copy is needed, whether you need the copy printed or digitally
- How long you need the book

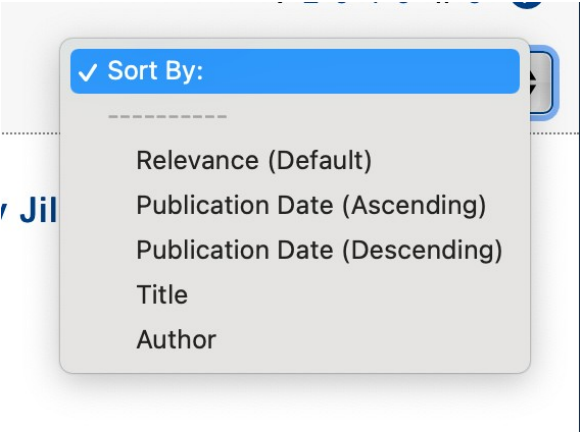
You can specify search results by author, title etc.:

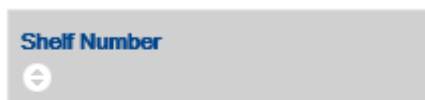
